CHAIR'S REPORT:

DIRECTOR'S REPORT:

Dr. Angela Dunn gave the Director's report.

Dr. Dunn updated the Board on the 2024 Budget. She let the Board know that the Mayor presented the budget to the County Council in October. Dr. Dunn also noted there is currently a hiring freeze. Human Services will present their budget to Council in November. The final budget should be approved by the County Council in December. Dr. Dunn mentioned the need to decrease costs in 2024 due to lower than expected revenue in property tax and sales tax. She mentioned the Health Department's inability to move forward with some new tax funded requests for the 2024 budget year.

Dr. Dunn informed the Board that the CARE Bureau received the Opioid Overdose to Action Funding which is a very competitive grant. This is a five-year funding stream of approximately \$900,000 per year and will fund 7 additional FTEs.

Dr. Dunn thanked Katherine Fife who was the interim Human Services Director for approximately the last six months. She expressed appreciation for all her help. Dr. Dunn also introduced Kelly Colopy who is the new Human Services Director.

VAPE ON MAIN APPEAL:

Dan Eckersley informed the Board that the subcommittee tasked with reviewing the Vape on Main appeal met, reviewed the Vape on Main case and recommended that the Board uphold the Chief Hearing Officer's final order. Michele asked if there was a motion to approve upholding the Chief Hearing Officer's final order. The motion was made by Pimmie Lopez, seconded by Mayor Marcus Stevenson, to approve to uphold the Chief Hearing Officer's final order. The motion passed unanimously, showing that all Board members present voted "Aye."
